Referenced bulet dated 2/3/61 stated [On 1/31/61, CIA advised that neither BRANDY nor DALZELL were connected with CIA and that CIA has no connection with operation described therein. (Reference to New Orleans airtel, 1/27/61.)] (S) (u)

With New Orleans airtel dated 2/16/61 captioned, "WILLIAM WAYNE DALZELL, INTERNAL SECURITY - CUBA (Bufile: 105-96938) were enclosed the originals of the enclosures to this communication. They represented material furnished by PCI, BETTY PARENT, which were hand-written notes allegedly discarded by subject, WILLIAM WAYNE DALZELL.

The Laboratory, by report dated 3/3/61, reported its analysis [of the cipher message as being a "substitution type cipher, utilizing for the most part three digit numbers to represent the letters of the alphabet." The decryption of that cipher message according to the laboratory was as follows:] (S) (u)

SUCCESS ORGANIZATION DEPENDS (UPON) CLOSE (AND IS AT YOU) HARMONY AND MUTUAL GOALS UNDERSTOOD. (S) (u)

(u) During the interview of WILLIAM WAYNE DALZELL on 6/2/61 in connection with the case entitled, "WILLIAM WAYNE DALZELL, IS - CUBA," DALZELL advised that through attorney, GRADY DURHAM in New Orleans he had been placed in contact with the CIA office in New Orleans. He explained that he was in late 1960 organizing a group known as "Free Voice of Latin America, Incorporated," which was to disseminate tapes to radio stations throughout Latin America, the purpose of which was to combat communism. DALZELL explained that he was interested in knowing whether or not this organization would in any way interfere [with CIA operations in Latin America.] (S) (u)
