The source advised that he knows of no headquarters or front having been set up outside the United States by TORRIENTE. [He commented that he has known TORRIENTE as a personal friend for many years; however, TORRIENTE has not confided in him with regard to specific plans of his group.] He has intimated that the United States Government knows something about this group and has taken no action whatsoever to discourage the group's activities. TORRIENTE has also indicated to the source that he will not violate any neutrality laws of the United States

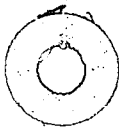
