Synopsis:

In August, 1965, subject was reported to be living in Denmark, with his book, "Rush to Judgment" scheduled for publication in England in October, 1965. During 1965, the subject reportedly: was the attorney for the YAWF; spoke at MLF meeting, Newark, New Jersey; was present at WWP headquarters where WWP members were mimeographing his book on the assassination of President JOHN F. KENNEDY; spoke at YAWF meetings held to protest American actions in Vietnam; was the payee on two checks drawn on the account of the YAWF and accepted invitation to a reception at the Czechoslovak UN Mission, NYC. The subject travelled to Europe 1964-1965, and delivered lectures on his version of the KENNEDY assassination in several countries.
