WEALTHY LANDHOLDER IN ORIENTE PROVINCE, CUBA ADVISED HE HAD RECEIVED
INFO FROM SEVERAL SOURCES INSIDE CUBA THAT IT WAS ANTICIPATED
APPROXIMATELY TWENTY THOUSAND MEN, WOMEN AND CHILDREN WOULD DEMONSTRATE
NEAR GUATANAMO BASE. FULLER UNABLE TO FURNISH ANY FURTHER INFO BUT
INDICATED INFO RECEIVED FROM INDIVIDUALS WITH WHOM HE WAS ACQUAINTED
IN CUBA AND WHOM HE BELIEVED TO BE RELIABLE. [ON OCT. EIGHT INSTANT ^{MIAMI} MM
FOUR NINE TWO DASH S ADVISED FIDEL CASTRO UPON HIS RETURN TO CUBA FROM
UN MEETING, NEW YORK, IN A PUBLIC SPEECH ANNOUNCED THAT CUBA WOULD
RETAIATE WITH US USING THE PHRASE AN EYE FOR AN EYE AND A TOOTH FOR
A TOOTH, WHICH ACCORDING TO INFORMANT COULD MEAN THE PICKETING BY
COUNTER-REVOLUTIONARY ANTI-CASTRO INDIVIDUALS IN NEW YORK CITY WOULD
BE RETALIATED BY PICKETING BEFORE GUATANAMO NAVAL STATION. INFORMANT
ALSO ADVISED DURING THE SPEECH OF CASTRO, PERSONALLY HEARD BY HIM,
WERE SEVERAL EXPLOSIONS REPORTED TO HAVE BEEN BOMB REPORTS. IN THIS
CONNECTION INFORMANT ASSERTED THAT BOMB SET OFF IN NEW YORK RECENTLY,
NOT FURTHER EXPLAINED, COULD HAVE BEEN WORK OF FIDELISTAS. INFORMANT
HAD NO INFO RE BOMB INCIDENT IN NEW YORK CITY OR ALLEGED DEMONSTRATION
