Information regarding MOORE, PAPINI, MATUZAK, HUFF, HYMERS and WHITE had been set forth in previous reports on subject union.

The indices of the Chicago Field Division contain no pertinent information regarding JOHN MARTINO.

On August 2, 1943, Confidential Informant JGO-77 whose identity is known to the Bureau, is a member of the Communist Party and advised that JOHNSON is a member of the Packinghouse Section of the Communist Party. (S) (u)

CHARLES LESTER has been the subject of an investigation by the Chicago Field Division. He has been reported to be a member of the 6th Ward Branch, South Side Section, Communist Party, and a subscriber to the "Daily Worker".

CURTIS SASSER has also been the subject of an investigation by the Chicago Field Division. He has been reported to be a member of the 5th Ward Branch, South Side Section, and a subscriber to the "Daily Worker".

Confidential Informant CGO-20 has advised that MARIE PYTEL of Local No. 108, Farm Equipment Union, was present at a meeting of the Communist Party trade unionists, held on March 4, 1944, at 1110 South Oakley Boulevard. (S) (u)

Confidential Informant T-5 has advised that JOSEPH SLISZ was a delegate from Local No. 108 to the American Slav Congress held at the Hotel LaSalle in Chicago on December 11 and 12, 1943. SLISZ resides at 2526 West Cortez. (S) (u)

Confidential Informant CGO-56 has advised that NICK PASQUA, Local No. 108, who resides at 167 West Locust, Chicago, was (S) (u)
