Following receipt of this summary on 9-2-56 the New York Office was notified of errors contained therein and subsequently furnished sets of amended pages 31, 52, 60, 65, 66, 83, 90, 91, 134, 135, 139 and 144. A review of these amended pages determined errors on pages 52 and 83. Additional amended pages of 52 and 83 were thereafter submitted. Inasmuch as all of the amended pages were received too late to include in the copies being forwarded to the Attorney General and Assistant Attorney General Warren Olney III in the letter to the Attorney General on 9-4-56, none of the amended pages have been utilized.
