ERNEST YOUNG is currently the Exalted Cyclops of the klan unit in the Bogalusa area of which HOWARD LEE had formerly been the Exalted Cyclops. This klan unit is located in the Mitch Community north of Bogalusa. LEE is believed to live in the Mitch Community and is a white male, 65 years of age, 5' 10", 200 pounds with a florid complexion. LEE's wife, whose first name is unknown, is also a member of the women's auxiliary of the klan.

BILLY C. MORRIS, who is a member of the OKKKK is in the ~~process~~ of adopting a child and has allegedly made a recent statement that for the next few months he is not going to be active in the klan as he wants to "keep his nose clean" so that there will be no hesitation about his obtaining this child.

On January 29, 1965, Klansmen ARVIS WARNER and PAUL COONE were overheard discussing a matter in which WARNER stated a Mrs. RICHMOND who lives next door to LOU MAJORS, the editor of the Bogalusa newspaper, had said that her husband, who is an attorney, would be glad to help the klan if they ever needed any help.

WARNER was also overheard to tell COONE that he had located some dynamite and that he wanted COONE and WAYNE
