MEMORANDUM FOR THE RECORD

SUBJECT: AMFOX-1: Message No. 30

1. Following is the text of a message from AMFOX-1 dated 6 December 1971 and received in MEXSAO on 5 January 1972.
2. "Tres cero (30). Diciembre seis (6). Recibo hasta ciento catorce (114).

"Alba de Fuente, que Jose de la VIGA, sobrino de Neneina, desde hoy dire Pepin, a quien en otras oportunidades nos hemos referido, dijo a Fuente, que se ha roto hace un mes, pieza de maquinaria en la que cada turno fabricaban seis toneladas jabones, y el prolongara todo cuanto pueda su reparacion. Que oportunamente le dara datos de junta de planificacion e industria ligera, que copie.

"Escuche la voz Alpha 66 por WRIZ 1550 KC (la primera estacion a la derecha de su radio) todos los Domingos de 4:30 to 5:00 de la tarde. Director Sr. Domingo MEDINA. Administrador Manolo CURA. Ausentismo sabotaje atentados. Alpha 66. Miliciano, soldado rebelde. Alpha 66 es una organizacion revolucionaria anticomunista formada por campesinos, obreros, estudiantes y antiguos miembros de la milicia y del ejercito rebelde. Nuestra lucha no es contra ti, es contra Fidel Castro y la pequena canarilla que traiciona nuestra revolucion entregandola al imperialismo ruso. Miliciano, soldado del ejercito rebelde, el Alpha 66 esta tu puesto de combate para liberar Cuba de la tirania comunista. Cuba espera por ti. Aunque Pepin aseguró que habian aparecido en centro trabajo, desconfio al presuntir que tal, sea acto provocacion de G-dos, ruego si posible nos saltes de duda al respecto.

"Posible proximo viaje Fidel a Argelia y compra de petroleo por Chile y Cuba a Argelia. Mas despues. Monte."

1. A search of the records systems of this Directorate in response to the referent request has revealed the following:

- a. The Secret Army Organization - We have no record.
- b. The Minutemen:
 1. One Document may be released in full. (Tab A)
 2. One index card which may or may not lead to information which is responsive to the request, should be referred to the Office of Security. (Tab B)
 3. Four documents which should be referred to the FBI. (Tab C)
- c. El Kamus Enterprises - One cable dated 2 January 1976 is denied under (b)(1), (b)(2), (b)(3) and (b)(6) of the FOIA.
- d. Alpha 66, California operations - One cable dated 2 January 1976 is denied under (b)(1), (b)(2), (b)(3) and (b)(6) of the FOIA. There is one other group of folders which could be searched for information on the subject; however, this

search would require approximately 16 hours of professional search time and would produce, we believe, very little if any information responsive to the request. We are informing you of the situation before making the search so the requester can decide whether he wants the search done, in view of the fee he must pay.

2. Attached is a completed form 3533 for the search already performed in connection with this request.
