3. COMMENTS: ABOVE PLAN FROM LITAU-1'S FATHER WHO REALIZES PROBLEMS INVOLVED BUT FEELS ALL POSSIBLE ASSETS SHOULD BE INTEGRATED IN SHOWDOWN AGAINST CASTRO.
