1. STAFFER MET IDEN 1 REF A FOR FIRST TIME 5 OCT. IDEN 1 STATED THAT QUITE APART FROM NOW HAVING JOB IN WAVE AREA HE GENERALLY RELUCTANT JOIN ROLANDO MASFERRER GROUP BECAUSE OF BLACK EYE THIS WOULD GIVE UNIDAD REVOLUCIONARIA OF WHICH HE WELL KNOWN MEMBER. STATED HE WOULD JOIN MASFERRER GROUP IF SO ORDERED BY HIS SUPERIOR AMBLEAK-1. AMBLEAK-1 INDICATED TO GO HE THOUGHT THAT PRESENCE IDEN 1 IN MASFERRER GROUP COULD INDEED PROVE HARMFUL TO UR STANDING.

2. IDEN 1 SAID FELT REASONABLY SURE COULD RECRUIT IDEN 2 REF A AS PENETRATION OF MASFERRER GROUP FOR ODENVY. POINTED OUT IDEN 2 HAS BEEN IN GROUP FROM START AND NEXT TO MASFERRER MOST KNOWLEDGEABLE AS TO GROUP ACTIVITIES AIMS ARMAMENTS AND FINDING SOURCES. STATES IDEN 2 ACTIVE IN GROUP PRIMARILY OUT OF DESIRE DO SOMETHING ACTIVE FOR CUBA BUT NOT NECESSARILY IN ACCORD WITH MASFERRER THINKING OR EXTREMISM. BELIEVES PITCH COULD BE MADE

ALONG LINES THAT ODENVY MUST ASSURE SAFETY AMERICAN PEOPLE BY KEEPING CHECK ON ANY GROUP TRAINING WITH WEAPONS FOR BELLIGERENT PURPOSES INSIDE AMERICA. WOULD ASSURE IDEN 2 THAT IT NOT ODENVY INTENTION DISBAND GROUP OR ARREST MEMBERS UNLESS INSIDE INFORMATION PROVED GROUP DEFINITE THREAT TO AMERICAN PEOPLE.

3. IDEN 1 STATES HE BELIEVES IT TECHNICALLY POSSIBLE ODENVY COULD RECRUIT IDEN 2 WITHOUT HIS AID AND HE NOT PARTICULARLY EAGER UNDERTAKE RECRUITMENT SINCE HAS JUST FOUND UNUSUALLY GOOD JOB HERE AND WOULD HAVE TO GET EMPLOYERS PERMISSION TAKE UNEARNED LEAVE. FEELS THIS PROBABLY WOULD REQUIRE OFFICIAL APPROACH TO EMPLOYER EXPLAINING SIMPLY THAT IDEN 1 SERVICES REQUIRED BRIEFLY BY GOVT. BELIEVES HOWEVER THAT RECRUITMENT IDEN 2 MORE ASSURED IF HE UNDERTAKES PITCH AND WILLING GO NEW YORK TWO-FOUR DAYS PROVIDED GOVT CAN COVER TRAVEL COSTS.

4. IDEN 1 EXPLAINED THAT HE HAD NOT BEEN ASKED TO JOIN GROUP BY MASFERRER BUT BY IDEN 2. THIS WAS IN SUMMER 62 AND HE REFUSED, EXPLAINING COULD NOT JOIN BECAUSE HE MEMBER UR. AGREED LOAN IDEN 2 HIS CAR FOR TRANSPORT AND OCCASIONALLY CONTRIBUTE MONEY AND OTHER SERVICES. IDEN 2 BORROWED CAR ON SEVERAL OCCASIONS TO FERRY TRAINEES TO TRAINING SITE SOMEWHERE IN NEW JERSEY. UPON RETURNING FROM ONE SUCH TRIP DRIVER HAD BURN ON UPPER INSIDE RIGHT ARM. EXPLAINED BURN WAS FROM BROWNING AUTOMATIC RIFLE WHICH HE HELD INCORRECTLY DURING WALING FIRE PRACTICE. IDEN 1 CANNOT REMEMBER NOW WHETHER IDEN 2 INDICATED NUMBER OF MEN IN TRAINING WAS 111 OR 116. REMEMBERS IDEN 2 STATING THAT SOME OF THE MEN RESIDED NEW JERSEY AND OTHERS NEW YORK CITY. IDEN 2 STATED PURPOSE OF TRAINING WAS TO MOUNT STRONG PARAMILITARY ATTACK INTO CUBA THIS YEAR.

INDICATED MASFERRER RAISING FUNDS THROUGH INDIVIDUAL CONTRIBUTIONS  
TRAINEES AND CAREFULLY SOLICITED CONTRIBUTIONS TO AVOID SECURITY  
FLAP AND OBFUSCATION OF OP BY ODENVY.

5. VERY SLIGHT PHYSICAL STATURE IDEN 1 INDICATES HE PROBABLY  
WOULD NOT PERFORM VERY IMPORTANT FUNCTIONS IN MASFERRER GROUP BUT  
WOULD PROBABLY ACT AS DRIVER AND GENERAL SUPPORT WORKER. ALSO AGREE  
PRESENCE IDEN 1 IN GROUP COULD BE HARMFUL FUTURE OF UR IN EXILE  
CIRCLES. THEREFORE SUGGEST ODENVY ACCEPT IDEN 1 OFFER RECRUIT IDEN2  
PROVIDED ODENVY STILL INTERESTED PENETRATE MASFERRER GROUP. REQUEST  
GUIDANCE AS TO WHETHER ~~OP~~<sup>WAVE</sup> SHOULD SEND IDEN 1 UP TO NEW YORK  
WITHOUT COORDINATING WITH LOCAL ODENVY UNIT AND WHETHER JWAVE  
SECURITY STAFFER CAN APPROACH IDEN 1 EMPLOYER TO OBTAIN LEAVE  
FOR IDEN 1. FINALLY WISH TO KNOW WHETHER JWAVE OR ODENVY  
TO REIMBURSE IDEN 1 FOR TRAVEL AND ANY LOST WAGES DUE TO TRIP.  
ALL INFO THIS FILE MAY BE PASSED ODENVY.
