No answer yet. Will tickle Mexi. 11 Feb if still no answer. Hold this ^{DA} on after tick that is cleared up. 3 vols of technical surveillance info in SO reviewed by me this date. 11 March 63 Charlotte says field has answered. Appears to be no problem.
