1. MICHAEL MALONE, HQS SOURCE NEW YORK, PASSED FOLLOWING REPORT FROM RELIABLE SOURCE MIAMI AREA:

ONE PATRICIO ESTEVEZ, A CUBAN CITIZEN, EMPLOYED HAVANA OFFICE SUN LIFE ASSURANCE CO. (A CARABIAN CORPORATION) WAS RECENTLY RETURNING ON TRIP FROM CURA AND RETURN. PATRICIO STATED THAT GOO KEEPS THREE BRITANNIA AIRCRAFT ON ALERT STATUS AT HAVANA AIRPORT IN EVENT LEADERS HAVE TO EVACUATE DCE UPPLISING OR OTHER CAUSES. PLANES WOULD GO TO PRAGUE VIA GANDER, NEWFOUNDLAND.
