1. IN RESPONSE YOUR REQUEST WE FUNDING AMIRCH ADDITIONAL \$40,000 FOR JUL BUDGET. WILL MAKE DEPOSIT 24 JUL.
2. ABOVE AMOUNT WILL INCLUDE \$26,475 FOR MILITARY STAFF SALARIES NOT YET PAID FOR JUL AND \$13,525 AS LUMP SUM TO COVER INDEFINITE AMOUNT NEEDED FOR "SOME BACK PAYMENTS DUE RECRUITS" AND "15 TO 20 CHECKS" FOR RECENTLY RETURNED MEMBERS STRIKE FORCE. WE COMPLYING THIS REQUEST FOR FOLLOWING REASONS: (A) TO AVOID TERMINATING SALARIES AND DEPENDENCY PAYMENTS WITHOUT ADEQUATE NOTICE, AND (B) TO AVOID FURTHER AGGRAVATING RESENTMENT BY MILITARY OVER HEAVY REDUCTION THEIR DEPENDENCY PAYMENTS AS COMPARED MUCH SMALLER CUT CIVILIAN BUDGET. HOWEVER, REQUEST YOU INSTRUCT AMTICKI-ONE TO SUBMIT SEPARATE AND DETAILED ACCOUNTING EXPENDITURES THIS \$40,000 AND REFUND ANY UNUSED PORTION.

CORRECT: AMYIKI-One advised that \$732,375 funded for Jul insufficient; needed \$26,475 cover military action staff salaries which included prior budgets and unstated amount to pay back payments due recruits and 15 to 20 dependency checks for recently returned Strike Force members. WAVE requested that Hqs fund AMIRCH and additional \$45,100 as soon as possible.
