1. DHEW MADE AUG PAYMENT ALL 1139 RETURNEES ON LIST PREPARED BY AMIRCH INCLUDING THOSE RESIDING OUTSIDE MIAMI AREA, AND WE HAVE NOW REIMBURSED DHEW FULL AMOUNT. AMIRCH DETERMINED ELIGIBILITY AND NO PAYMENTS WERE WITHHELD FROM RETURNEES THEIR LIST. THEREFORE THE SOME 75 RETURNEES WHO ALLEGEDLY DID NOT RECEIVE AUG PAYMENTS WERE APPARENTLY NOT INCLUDED ON AMIRCH LIST. AS STATED IN NOTICE, AFTER AUG NO FURTHER PAYMENTS WILL BE MADE TO RETURNEES EXCEPT BY DHEW ON SAME BASIS AS FOR OTHER CUBANS. WE CONSIDER THIS CLOSED MATTER AND REQUEST YOU INFORM AMFIKI-1 REGRET NO FUNDS AVAILABLE FURTHER PAYMENTS TO RETURNEES.

2. RETURNEES RESIDING OUTSIDE MIAMI AREA WHO WISH ESTABLISH ELIGIBILITY FOR CONTINUED BENEFITS SHOULD WRITE DHEW MIAMI AT ADDRESS GIVEN IN NOTICE, REQUESTING APPROPRIATE ARRANGEMENTS BE MADE WITH DHEW OFFICE IN LOCALE THEY RESIDING.

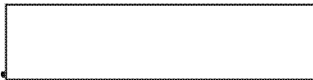

WH Comment: \*Requested approval to consider, on individual basis, further monthly payments through AMICOR to some 25 returnees in Miami area who did not get Aug payments because they considered permanent residents not refugees and unable find jobs in saturated Miami job market. Also said some 50 returnees residing outside Miami area unable get Aug benefits for lack of knowledge of a place to apply. Asked where and how should these persons apply.
