1. HURWICH STATEMENT EMPLOYEES ARE POSSIBLY SUBJECT MISINTERPRETATION BY HEADQUARTERS FROM POSITION WITH WHICH COACID IS AGREEMENT IS AS STATED REF B. MESSAGE WAS GIVEN FUNDS FOR SALARIES OF EMPLOYEES WHO PERFORMED VARIETY OF DUTIES INCLUDING ISSUING HIGH BULLETINS AND PREPARING BOARD PROGRAMS. SINCE THIS GROUP ASSIMILATED BY AHEAD HQS EXPECTS SALARIES TO COME FROM BASIC BUDGET. ADDITIONAL FUNDS WILL BE PROVIDED FOR NEW PROJECTS WHEN APPROVED BY HQS.

2. HQS CONSIDERS ESSENTIAL THAT LINE BETWEEN BASIC BUDGET EXPENSES AND NEW OPERATIONS BE CLEAR-CUT AND BE ESTABLISHED BEFORE NEW OPERATIONAL PROJECTS ARE PROPOSED. PARA TWO REF B IS PRACTICAL SUGGESTION FOR ESTABLISHING LINE.

WE COMMENT: OBSERVED OUT APPARENT INCONSISTENCY BETWEEN HQS INSTRUCTION (40) THAT EXISTING SALARIES OF CRC PROPAGANDA SHOULD BE DEFRAID FROM MONTHLY ADMINISTRATIVE BUDGET AND HURWICH STATEMENT TO MIBO CARDONA THAT FUNDS FORMERLY GIVEN TO ADEL MESSAGE FOR PROPAGANDA WILL NOW BE GIVEN TO CRC.
