1. DESIRE STATION DISPATCH STAFF AGENT OR SOMEONE EQUIVALENT CONFIDENCE TO CANARY ISLANDS AND THERE SEND IDENTICAL TELEGRAM IN SECURE MANNER TO THE ADDRESSEES MOSTLY IN FLORIDA. PERHAPS WILFRED D. CLOWER LOGICAL MAN FOR JOB. NO-CASE GOAL IS MAKE EX-CUBAN PRES BATISTA APPEAR TO BACK UNDESIRABLE EXILE GROUPS AGAINST HUBARK SUPPORTED ANTI CASTRO FRONT. CHOICE OF CARRIES THE PROXIMITY BATISTA EXILE LOCALS MADEIRA AND OTHER OF FACTORS. SINCE THIS PART OF MULTIPLE INTERDEPENDENT OPERATIONS WOULD APPRECIATE ALL POSSIBLE SPEED.

TH URGENTE. TODOS AMIGOS PROSEGUIR INMEDIATAMENTE INTENSA CAMPAÑA DESACREDITAR AL CONSEJO REVOLUCIONARIO DE MIRO. UTILIZAR TODOS MEDIOS: PERIODO, RADIO, REUNIONES LLAMAR ATENCION Y DECLAR OPINION AL CONSEJO. EXITO DE NUESTROS FUERZAS EN PROXIMO FUTURO IMPOSIBLE SI GRUPO MIRO LLEGA FERRIBAR BOLA DE CARRRE. HAY QUE IMPEDIR QUE CONSEJO HAGA CAPITAL PRINCIPAL. PANCHIN TIENE FONDOS. TIGRE TIENE MATERIALES. (SIGNED) FERNANDO BRAVO."

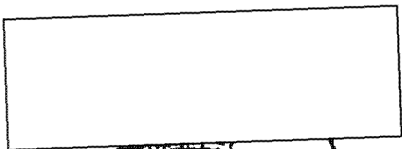
