1. HAD SHORT MEET WITH SUBJ LATE EVENING 5 MARCH. IN ADDITION DISCUSSION AMNSNAKE I MATTER, WHICH FOLLOWS SEPARATELY, SUBJ STATED HE VERY WORRIED AT PRESS REPORTS ROLANDO CUBELA ARRESTED IN CONNECTION PLOT AGAINST CASTRO. PER GNVA 7668, SUBJ PRESENT IN PARIS AT CHRISTMAS 64 WHEN CUBELA ALSO VISITING THERE. IN CONVERSATIONS WITH SUBJ AND CARRILLO, CUBELA SHOWED SOME BITTERNESS AT REGIME FOR PRESENT SIDELINE POSITION. ON AT LEAST ONE OF SEVERAL OCCASIONS WHEN SUBJ, CUBELA, CARRILLO TOGETHER, STUDENT PRESIDENT JOSE REVELLON ALSO THERE.

2. WHAT WORRIES SUBJ MORE THAN PAIRIS CONTACT, WHICH AFTER ALL IN EFFECT UNDER CARRILLO AEGIS, IS FACT THAT WHEN HE WENT HAVA FROM N.Y. FALL 65, AT REQUEST CUBELA LONG TIME FRIEND MARTA JIMENEZ, SUBJ TOOK PACKAGE WHICH ALLEGEDLY CONTAINED BOOKS TO CUBELA. SUBJ STATES THAT GIVEN CLOSENESS OF JIMENEZ TO CUBELA, MIGHT WELL BE MIXED UP IN ANY ANTI-REGIME ACTIVITY CUBELA HAS UNDERTAKEN, IF PRESS REPORTS TRUE.
