1. ANLASH/I WAS ADVISED PER REF 1130 HOURS 3 FEB. HE WAS VISIBLY MOVED AND DISILLUSIONED WITH NEGATIVE REPLY. STATED HE DECEIVED HIMSELF INTO BELIEVING THAT OUR LONG RELATIONSHIP HAD DEVELOPED MUTUAL CONFIDENCE, BUT APPARENTLY HE WAS WRONG. CLAIMS HE WOULD HAVE NEVER MADE REQUEST IF HE HAD HAD SLIGHTEST DOUBT REQUEST WOULD BE REFUSED.
