<p>Action Required: FYI</p> <ol style="list-style-type: none"> 1. AMNUBA-1 resigned from the AMLILACs effective 31 August 1964. An Agent Service Record and a Damage Report are attached. 2. AMNUBA-1 was a well-trained commando and radio operator with a good record in the AMLILAC group. He was a hard worker, was well motivated, and was well-suited for a commando role. He became disillusioned with the operational inactivity of the AMLILACs and reluctantly resigned. 3. There is little doubt that he will seek employment with some exile group that will offer him the action he seeks. It is possible that he will attempt to join AMWORLD. Due to the fact that Subject participated in Operation ZORRO, a caching operation in support of AMLASH-1 and not yet recovered, it is necessary that Subject be held in PBPRIME until it is determined if the cache is to be recovered.
