DESENSITIZED TYPIC AMWHIP

1. AMWHIP/1 (A/I) DELIVERED SEALED LETTER TO PARI VIA <sup>02</sup>(UNSNAFU/9) ON 12 APRIL. SUMMARY AS FOLLOWS: A/I SAW <sup>02</sup>(UNSNAFU/19) <sup>02</sup>(U/19) FOR SHORT TIME 9 APRIL. <sup>02</sup>(U)19 TOLD A/I THAT INFO CONCERNING "THE MATTER" HAS BEEN SENT TO IDEN <sup>A</sup>THRU PBRUMEN AMBASSADOR IN ALGI WITH INSTRUCTIONS THAT IT BE GIVEN PERSONALLY TO AMHUG/1. A/I BELIEVES <sup>02</sup>(U)19 HAS ALREADY DISCUSSED MATTER WITH PBRUMEN. STATES AMBASSADOR ALGI LEFT FOR PBRUMEN WITH AMHUG/1 BROTHER. MEANS AND DATE UNKNOWN. A/I ASKED <sup>02</sup>(U)19 IF LATTER WISHED A/I INQUIRE FURTHER OF <sup>02</sup>IDEN BUT <sup>02</sup>(U)19 WANTS WAIT UNTIL PBRUMEN REACTS. <sup>02</sup>(U)19 STATED WILL WRITE TO A/I <sup>02</sup>IN NEW YORK OR ADVISE VIA AMWHIP/2. *Cellato 02* *Tden 8*

2. A/I STATES HE PREPARED GROUND WORK TO SEND ANTIQUITIES EXPERT TO PBRUMEN BUT DATE STILL UNCLER.

3. A/I WILL TELEPHONE <sup>02</sup>(U)19 THIS WEEK AND MAY PASS BY PARI AT END OF WEEK IF NECESSARY.
