1. AMWHIP/1 EUROPEAN TRIP DELAYED DUE FATHER'S OPERATION WHICH SUCCESSFUL. WILL LEAVE EVENING 23 MARCH. PLANS FIRST STOP MADR THEN PARI, FOLLOWED BY GENEVA, MILAN, ROME. TOLD GIVE ANY PERISHABLE INFO RE AMLASH/2, AMLASH/3 TO ROBERTO IN PARI. OTHERWISE WILL DEBRIEF NEW YORK UPON HIS RETURN.

2. GIVEN GENERAL BRIEFING PER REF. SEE NO HARM FURTHER DISCUSSION SECURITY SITUATION IN FRANCE AND EUROPE BY ROBERTO. FYI, AMWHIP/1 EXPRESSED CONCERN MEETING ROBERTO TOO FREQUENTLY AT HOTELS. PREFERENCES NON-PUBLIC PLACE SUCH AS SAFEHOUSE. DEFER TO ROBERTO THIS MATTER.
