SUBJECT: Meeting with LITAMIL-9, 1 April 1964

4. L-9 reported as follows:

J. L-9 turned over the [redacted] letter to MIRABAL. MIRABAL seemed to feel he had a hot potato on his hands, was very uncomfortable and even a bit scared and said, "I'll have to discuss this with the Ambassador." (L-9) notes that MIRABAL is cowardly, timorous, not at all like his predecessor AZCUB who was the epitome of self confidence and control. (L-9) finds this interesting since AZCUB was not a Communist and MIRABAL is — the Communist is really the weakling in spite of all the strength that supposedly comes from knowing that Marxism-Leninism is right.)

SUBJECT : Meeting with L-9 30 Jan 1964

1. A meeting with L-9 took place from 2010 until 2145 hours 30 Jan 1964 at the safe apartment. L-9 was in surprisingly good spirits, showed none of his usual depression.

2. L-9 reported on the following:

a. On Saturday 18 Jan at the usual Embassy staff meeting, several new assignments were passed out. A "three month plan" was announced and during this period staff members, in addition to their usual duties, will prepare special reports on several topics. Raul APARICIO will do a report on the National University -- physical plant, student body, activities, ways in which the Cuban government can exert influence, etc. L-9 will [redacted]

MACHADO will do a report on countries which have diplomatic relations with Cuba -- emphasizing how contact with representatives here in Mexico of such countries may be parlayed into something more worthwhile for the Castro government. Rogelio RODRIGUEZ was given an assignment as Political Reporting Officer.

At this meeting Guillermo RUIZ of the Commercial Office -- who has recently been emerging as a fanatical Fidelista -- spoke out about the recent accord between the USSR and Cuba, saying that it was convenient for the USSR to keep on the good side of Cuba and thus keep a dagger in the back of the imperialists. Ambassador HERNANDEZ Arvas, somewhat taken aback by RUIZ' language, pointed out that the relationship between the USSR and Cuba is based, above all, on the highest principles of international friendship.

b. Last Wednesday (29 Jan) a Soviet official, Boris T. RUDENKO, visited the Cultural Department and spoke with APARICIO and L-9. L-9 took pains to "be a good Communist" during this encounter. (This conversation was picked up by CONTRAP) RUDENKO was also at the home of Horacio FLORES Sanchez on the 28th after the Marti bazaar session at the Cuban Cultural Institute.

c. A Bolivian woman -- name possibly VILLALBA -- was recently at the Hotel Oxford with 7 children, waiting to go to Cuba to join her husband who works there. L-9 believes she has gone on to Cuba.

d. On 17 January Cuban delegates to the CEPAL Conference visited the Embassy and spoke with Embassy employees. One of these delegates, referring to the Nicaro plant in Cuon, said that only 12 engineers of the original 37 remained. Of these, a man named (fnu) PRESILLA was still doing an excellent job although he is physically in poor condition. The Nicaro plant specifically, and technicians throughout Cuba in general, are having a hard time with the decimal system used by the USSR in its technical equipment. The delegates said that it was now apparent that Cuba will definitely plan to base its economy on sugar -- that Fidel CASTRO had at last made this quite clear.

f. On 23 January Oscar CONCEPCION was standing at the gate when the mailman arrived with a letter for the Ambassador. This letter was from Lic. DIAZ Ordaz — CONCEPCION said, "I saw it with my own eyes, the envelope had DIAZ Ordaz' name on it."

g. On 29 Jan a Venezuelan woman named Suzana BEJARANO came to the Embassy. She was staying at the Hotel Virreyes, Room 402. She was trying to sell exhibition rights to a film entitled "Tú y Crimen" which had been filmed in Venezuela and shown only twice before the government shut it down and prohibited future showings, labelling the film as of "improper social tendencies." BEJARANO said that she planned to stay in Mexico about a week and would also contact the Soviet and Czech Embassies in an effort to sell the film and recoup some of the cost of producing it. She was told that her proposition would be relayed to Havana.

h. A young Cuban doctor, named Silvrio REYES, is in Mexico City and trying to return to Cuba. He was in the Embassy on 29 Jan and has been there before.

j. After the affair at the Institute a group of those present went to the home of Horacio FLORES Sanchez of Pallas Artes. CARBALLO did not want to go for some reason unknown to L-9. While at FLORES place, L-9 saw that Raul PEREIRA "Raulito" seemed very interested in FLORES Sanchez and asked a number of questions about him. L-9 says that FLORES is a well known homosexual. (LIENJOY shows that Raul PEREIRA is also homosexual possibly)

k. Several days ago Ana Berta ORTEGA de ARAUJO came to visit the Cultural Department. She was accompanied by the brother of the Mexican Berta MAGALLON — he is a dancer. She said she is director of the "Tita" dancing studio located at Monte Ararat, corner of Sierra Leona, Lomas Barrilaco. She would like to go to Cuba to soak up some culture.

After Teresa PROENZA was seen off at the airport, Oscar CONCEPCION "revealed" that she had been fired on orders of President DORTICOS who got tired of receiving reports that a famous international sex deviate (famosa "tortillera" internacional) was working at the Embassy. p. On Wednesday and Thursday (29 and 30 Jan) URBIETA, an employee of the Commercial Section, was grumbling about the "kids" who supposedly work there -- REYES, CONTRERAS, and GARCIA -- but who can't seem to get anything done and only succeed in messing up paper. URBIETA was quite disgusted.

q. Guillermo RUIZ has been showing himself to be quite aggressive politically in staff meetings. He appears to be a violent partisan of the Castro regime.

u. On Sunday 26 Jan a group of Chinese acrobats paid a courtesy visit to the Embassy. The leader of this group said that Senator Manuel YDRENO Sanchez would soon be going to China.

v. On Monday 27 Jan Dolores DE LA CRUZ was at the Embassy. She said she hopes to go to the US to cover the Johnson-Lopes Mateos interview. She came with Dorinda HEDGES, divorced wife of a former ~~American Ambassador to Brazil (Brazilian Embassy country)~~ Dolores said that DIAZ Ordaz and Ambassador DE NAJBEZ Arvas are great friends and that she had seen an envelope which DIAZ Ordaz sent to the Amb. w. An American named Fred BALDASARE, a swimming champion, has been in the Embassy trying to implement his plan to swim from Cuba to Florida and set a new world record. APARICIO remarked to L-9 that if they let this nut train a Cuban to make this swim (as he wants to do) it would probably result in thousands of Cubans doing the same thing to get out. (LENNY and STRAP have picked up BALDASARE).

x. Some youngsters from a group called the "Movimiento Cultural Mexicano" have been trying to establish good contacts with the Embassy. The president is José MARTÍNEZ, phone 23-24-39. The Vice-President is Rafael GONZALEZ, phone 21-17-63, address Avenida Central No. 266-S, Colonia Pro Hogar. The Subsecretary of Organization is Manuel GONZALEZ, phone 13-36-73. They had their first "Cultural Festival" on 26 July 1963 "as proof of the

extent of their love for the Cuban people." L-9 does not know much about this group, feels it is being investigated.

3. L-9 asked B to get him a book about the painter Archie JOEKY. This book is published by the Whitney Museum of American Art, The Macmillan Company, New York, 1957. It will be ordered from BRS separately.

4. The meeting had to be cut short since B had to go elsewhere to meet and assess an agent prospect who was planning to leave Mexico City the next morning. Accordingly, it was agreed that another meeting would be held on Tuesday 4 February at 2000 at the safe apartment. L-9 will be paid his January salary at that time.
