1. TELEPHONE RECEIVED COPY OF LETTER FROM [illegible] TO APRIL COVINO OFFERING HIM JOB AS ORGANIZER IN 1964 AND AUTHORIZING HIS CODE NAME FOR ORGANIZERS CONFERENCE. TELEPHONE POINTED OUT COVINO'S UNLAWFUL REPUTATION AND SUGGESTED CHECK WITH OWNERS.

2. COVINO SAYS HE WOULD NOT HIRE COVINO UNDER ANY CIRCUMSTANCES. HE CONSIDERS COVINO A CROOK, ONLY INTERESTED IN MONEY AND UNDOUBTEDLY WOULD BRING IN POLITICAL WASTE OF FEDERAL FUNDS. COVINO SAYS COVINO WAS CHIEF IDEALLY OF MANAGEMENT OF FUNDS, NOT IF COVINO MANAGES THIS COMPANY A TECHNICALITY AND HE OWES \$125,000. TELEPHONE SAYS HE WILL BE ANOTHER REFUGEE. THIS OFFER MADE WITHOUT COVINO'S KNOWLEDGE.

3. COVINO EMPHATICALLY HAS CLOSE TIES WITH CIA AND PARTICULARLY RAY BERRY. HIS BELIEVES WAGON AND HIS CONSPIRACIOUS CURRY SHOULD BE SERIOUSLY RECONSIDERED IMMEDIATELY. FURTHER REVIEW COULD BE BY APPROVAL OF ONLY SIX MONTHS REVIEW. WOULD RECOMMEND REALISE RESEARCH MAY BEING HELD OFFER BELIEVE HE SHOULD GIVE SERIOUS CONSIDERATION TO OFFICE OF U.S. ATTORNEY. CERTAIN AUTHORIZED SOURCE SO SPECIAL FUNDS WILL BE AVAILABLE FOR ANY PROGRAM HANDLED BY COVINO.
