1. IN VIEW POSITIONS SAADIG AND CLAUSSEN PLUS INFO CONTAINED IN REFS C AND D, CONSIDER IT PROBABLE THAT BEER DELEGATION WILL SUPPLY DETAILS PURCHASE 20,000 TONS WHEAT AND POSSIBLY NEGOTIATE FOR MORE WHEAT.

2. ALSO HAVE ODACID REPORT THAT BEERS HAVE DISCUSSED PLAN WITH SWISS BANKERS UNDER WHICH BEER WOULD SELL \$400,000 TO \$500,000 WORTH OF "THIRD COUNTRY" WHEAT TO BRAZIL FOR DOLLARS.
