Findings: There was no information relating to the terms of reference.

Of interest are the attached two cables concerning travel to the U.S. of five Cuban Government agents to abduct Cuban opposition leader Manuel Antonio "Tony" VARONA.

SUBJECT: TRAVEL TO THE UNITED STATES OF CUBAN GOVERNMENT AGENTS

1. ACCORDING TO A USUALLY RELIABLE SOURCE WITH GOOD CONTACTS IN CUBAN OPPOSITION CIRCLES, FIVE CUBAN GOVERNMENT AGENTS HAVE LEFT CUBA FOR THE UNITED STATES, THREE EN ROUTE TO MIAMI AND TWO TO NEW YORK. THE PURPOSE OF THEIR TRIP IS TO ABDUCT MANUEL ANTONIO ("TONY") VARONA, CUBAN OPPOSITION LEADER.

2. VARONA IS IN MEXICO AT THE PRESENT TIME BUT PLANS TO RETURN TO THE UNITED STATES. FURTHER INFORMATION RECEIVED ON THE ABOVE SUBJECT WILL BE MADE AVAILABLE TO YOUR BUREAU.

3. THE ABOVE INFORMATION IS BEING MADE AVAILABLE TO THE IMMIGRATION AND NATURALIZATION SERVICE.
