1. ACTION REQUIRED: FYI.

2. ACOS CONTACTED SUBJECT [redacted] WHO VISITED [redacted] IN THE STATION AFTERNOON 12 MARCH. HE READ REF TEARLINE AND WENT THROUGH REF PARA 3 A-F QUESTIONS AND ANSWERS. SUBJECT SAID THAT IN HIS CASE, GROUNDS FOR POSTPONEMENT OF PUBLIC DISCLOSURE MIGHT BE FOUND UNDER SUBPARAS 3 AND 4. HE NOTED THAT HE IS LIVING OVERSEAS UNDER COVER AND THAT REVELATION OF HIS ASSOCIATION WITH [redacted] WOULD INVADE HIS PRIVACY AND COULD POSE A SECURITY PROBLEM. SUBJECT ALSO ASKED FOR ANY INFORMATION REGARDING THE DOCUMENTS WITH WHICH HIS NAME IS ASSOCIATED, AS HE HAD NO RECOLLECTION AT ALL OF ANY INVOLVEMENT WITH \*AN INVESTIGATION OR CORRESPONDENCE RELATED TO THE <KENNEDY> \* <ASSASSINATION.> FOR THE RECORD, SUBJECT'S ADDRESS PROVIDED IN IDEN [redacted] REF IS ACCURATE.
