1. SHRYOCK CONTACT LITAMIL 1 HAS DEVELOPED EXTENT THAT ON 5 NOV LATTER TOLD [REDACTED] PAMPHLET AND OSTENSIBLE [REDACTED] ENVELOPE BROUGHT HIM BY "FRIEND" WHO OFFICIAL U.S. EMBASSY. WHEN AMB WANTED PUBLISH NEWSPAPER ARTICLE DENOUNCING PAMPHLETS AND ENVELOPES "PHONY" LITAMIL 1 CONVINCED HIM WAIT AS "FRIEND" WANTS INVESTIGATE CASE FURTHER (LIFEAT B2). AS OF 13 NOV NOTHING HAS APPEARED IN PRESS RE FLYSHEETS.

2. STATION HOPEFUL [REDACTED] AMB WILL REFRAIN FROM PUBLISHING ANYTHING RE FLYSHEETS ORDER HELP KEEP SECURITY THIS CONTACT WITHIN CIRCLE LITAMIL 1, [REDACTED] [REDACTED] ALTHOUGH LITAMIL 1 KNOWS TRUE NAME SHRYOCK STATION NOT ABLE ASCERTAIN THIS DATE WHETHER NAME PASSED AMB OR [REDACTED] LITAMIL 1 INSISTS WILL NOT DIVULGE.

3. STATION PREOCCUPIED POSSIBILITY "LEAK" MAY REVEAL STATION CONTACT WITH [REDACTED] TO ODACID CHIEF MEXI HOWEVER LITAMIL 1 DIRECT CHANNEL [REDACTED] AND APPARENT CONTROL OVER SOME ACTIVITIES AMB PRESAGES POSSIBLE KUTUBE POLITICAL ACTION CHANNEL WORTH CULTIVATING, WEIGHING SECURITY RISKS.

4. NIGHT 11 NOV WHILE IN AREA CUBAN EMB WITH LITAMIL 1 LATTER MET UNEXPECTEDLY [REDACTED] AND ONLY INTRODUCED HIM SHRYOCK WITH NO MENTION NAME. LITAMIL 1 [REDACTED] S-E-C-R-E-T
