Captioned individual was interviewed by Mr. John G. Gossett, Acting Consul General, American Embassy, Paris, on December 9, 1963 in connection with GIBSON's knowledge of LEE HARVEY OSWALD and his alleged activity in the "Fair Play for Cuba Committee. The results of that interview have been reported in connection with the case captioned "LEE HARVEY OSWALD, IS - R."

* Darwin Curtis, of CIA, Paris, has advised that GIBSON may be of interest to them in the future. He is presently residing in Paris. It appears that CIA may attempt to develop GIBSON as a source of information. This is furnished for the information of the Bureau and the completion of Bureau files.

No further action being taken by this office in the absence of specific request. Any further pertinent information received regarding GIBSON will be furnished to the Bureau.
