THE CUBAN GOVERNMENT INTENDS TO EXECUTE BOSCH AND POSADA, EITHER WITH OR WITHOUT DUE PROCESS OF THE LAW.

2. DESPITE HIS YEARS IN EXILE, BOSCH IS CONSIDERED BY THE CUBAN GOVERNMENT TO BE A CUBAN CITIZEN, HERNANDEZ SAID, AND THE CUBANS WILL REQUEST THAT HE BE TURNED OVER TO THEM FOR PROSECUTION. IN THE CASE OF POSADA, HERNANDEZ SAID THAT THE CUBAN GOVERNMENT WILL REQUEST THE VENEZUELAN GOVERNMENT TO REVOKE HIS VENEZUELAN CITIZENSHIP AND THEN TURN HIM OVER TO CUBAN AUTHORITIES, IF THEY WERE TURNED OVER THROUGH LEGAL MEANS, HERNANDEZ SAID THAT BOTH BOSCH AND POSADA WOULD BE GIVEN A QUICK TRIAL IN CUBA AND THEN EXECUTED WITHIN THREE HOURS. SHOULD THE CUBAN GOVERNMENT BE UNABLE TO GAIN POSSESSION OF BOSCH AND POSADA THROUGH LEGAL MEANS, THE CUBANS WILL TAKE STEPS TO LIQUIDATE BOTH.

(SOURCE COMMENT: HERNANDEZ DID NOT INDICATE WHETHER EITHER BOSCH OR POSADA WOULD BE RETURNED TO CUBA FOR TRIAL IF ACCESS TO THEM WAS OBTAINED EXTRA-OFFICIALLY.) IN ANY CASE, HERNANDEZ SAID, THE CUBAN GOVERNMENT HAS DECIDED THAT BOSCH AND POSADA MUST DIE FOR THEIR PART IN THE CUBANA DISASTER. (FIELD COMMENT: A USUALLY RELIABLE SOURCE INDEPENDENTLY REPORTED THAT
