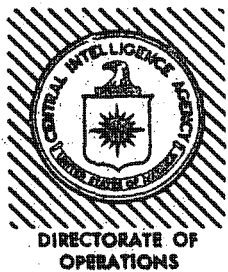

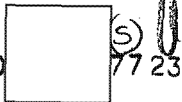

THE CUBAN INTELLIGENCE SERVICE (CUI) THROUGH THE CUBAN EMBASSY IN CARACAS. THE INFORMATION WAS PROVIDED IN THE FORM OF LETTERS, ACQUIRED FROM A CUBAN PENETRATION OF THE COORDINATED UNITED REVOLUTIONARY ORGANIZATION (CORU). THESE LETTERS WERE INTERCEPTED BY A CUI SOURCE AND FORWARDED TO HAVANA FOR CLANDESTINE OPENING AND REVIEW. CUI ANALYSTS COMPARED THE LETTERS WHICH REPORTEDLY ORIGINATED WITH JAILED CUBAN EXILE LEADER ORLANDO BOSCH WITH HANDWRITTEN PAPERS AND SIGNATURES AVAILABLE AT HAVANA UNIVERSITY. <sup>Cuba</sup> THE HANDWRITING OF THE INTERCEPTED LETTERS WAS CONFIRMED BY THE CUI AS THAT OF BOSCH'S. THE TEXTS OF THE LETTERS WERE COPIED AND A COPY OF THE LETTERS AND A CUI ANALYSIS OF THE CONTENTS WERE MADE AVAILABLE TO THE VENEZUELAN DIRECTORATE FOR THE SERVICES OF INTELLIGENCE AND PREVENTION (DISIP) AND TO VENEZUELAN PRESIDENT CARLOS ANDRES PEREZ.
