On 2/21/66, information was received from Central Intelligence Agency that its source, "Sugar," known to your office, had advised that on 1/26/66, while in Brussels, Belgium, he met a woman who called herself Lisa Armand. She advised "Sugar" that she was there for talks with Jacques Grippa, who is the leader of the pro-Chinese faction of the Belgian Communist Party, concerning the defense for William Epton. Following "Sugar's" conversation with Armand, he checked the hotel register where Armand was staying and determined that her passport identification listed her as Mrs. Frank. (S)
