Customs has an informant who is a pilot, ORLANDO BOSCH plans to use this pilot and has contacted him. BOSCH has used this pilot before on other proposed flights. Customs expects to have coverage on this matter.

On 5/12/66, [Mr. AUSTIN HORN, Covert, CIA, Miami] and [Colonel FRANKLYN BITHOS, USAFAD Miami,] advised their agencies had no operational interest in the flight or ORLANDO BOSCH. (S)(X)(U)
