Information contained herein was obtained from [NY 5812-S*] on dates indicated by SAS JUELL R. (S) NESS, and (S) THOMAS D. J. BROOKS, and Mr. [redacted] (S) of the Central Intelligence Agency. [NY 5812-S*] is a confidential informant, contact with whom has been insufficient to establish his reliability.

In the event KGB code names appear in this memorandum, they are not to be further disseminated.

Source advised as follows on 8/16/67:

Source advised that ["KRAM"] is the KGB code name (S) for MARK LANE, a lawyer and the author of a recent book critical of the Warren Commission findings on the assassination of President KENNEDY. Source further advised that BORIS OREKHOV, a KGB Officer assigned to the NY Residency, had two meetings with LANE and had established a "trusted relationship" with LANE. Source stated, however, that LANE had gone to Europe and after his return, LANE was not contacted.

Source also stated that the NY Residency of the KGB had established "conditions of meetings" with ["KRAM."] (S)

BORIS M. OREKHOV, a Soviet national, was employed as Information Officer, Office of Public Information, at the UN Secretariat. OREKHOV was in the US during the period February 12, 1964, to June 17, 1965. He returned to the US on 8/19/65, and last departed this country on April 2, 1966.

The above information is submitted for review and evaluation.
