ReNYlet to Bureau, 11/5/66 and Bureau authori-  
zation to interview subject dated 11/23/66.

Enclosed for the Bureau are nine copies of an  
LHM, dated and captioned as above.

The subject was not interviewed until 1/9/67,  
inasmuch as he had moved from his previously known address  
and was on a three week vacation in Florida over the holiday  
season.

During the interview the subject claimed he knew  
nothing of any kind of meeting or conference in Santiago,  
Chile, while he was there in February, 1966. He said that  
he did not attend such meetings and also that he was very  
pro-United States.

It appears that the information in the original  
allegation in this matter from CIA to the effect that VICTOR  
DELGADO, with re-entry permit number 9245, was present at  
Communist Youth Congress in Santiago, Chile, was probably  
obtained from [redacted]

Inasmuch as this subject on interview  
stated he displayed his travel papers to no other persons  
or agencies. It is also noted that he had a visitors visa  
to enter Chile which was probably the case of all the delegates  
and observers to the Communist Youth Congress.

All sources who know the subject advised during  
this investigation that he, although unactive, is anti-  
CASTRO, he desires to become a United States citizen.
