On 2/27/61 Central Intelligence Agency (CIA) by
liaison advised that the following information had been
received from a Cuban refugee source of unknown reliability. (S)(u)

The source claimed the subject, who recently arrived
in Miami, had served as a secretary to Castro. In addition,
the source also disclosed that the subject was well known to
pilots of Cubana Airlines and had been in contact with
Hector Garcia, whom source characterized as a "Castro agent." (S)(u)

On 3/17/61 CIA identified the source of the above
information as [redacted] CIA indicated it had
no objection to Bureau's contacting [redacted] and
disclosed that that individual could be located through the
CIA representative in Miami. (S)

Contact [redacted] (S) and obtain specific
information concerning allegations against the subject.
Furnish information obtained together with your recommendations
for future action in this matter.
