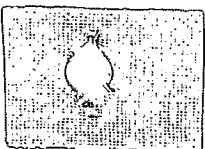

No investigation pertinent to your inquiry has been conducted by the FBI concerning the captioned individual. However, the files of this Bureau contain the following information which may possibly relate to the father of the subject of your name check request.

A confidential informant who has furnished reliable information in the past advised that on November 8, 1960, one Paul Giorno was in contact with Jose Moleon at which time he invited Moleon to his home for dinner on November 13, 1960. According to the informant Moleon, Military and Air Attache, Embassy of Cuba, Washington, D. C., tentatively accepted the invitation but suggested that Giorno come to the Embassy to discuss it further on November 9, 1960. (S)(U)

Another confidential informant who has furnished reliable information in the past advised that an individual driving a motor vehicle registered to Paul Giorno, 3247 Terrace Drive, Silver Hill, Maryland, visited the Cuban Embassy, Washington, D. C., on November 9, 1960. (S)(U)

Files of this Bureau further reveal that a complaint was made by one Michael D. Parise, 4623 Davis Avenue, Suitland, Maryland, on December 8, 1955, concerning his nephew one Paul Giorno with whom he was at one time in business. Parise advised that about three months prior to his complaint he had received an anonymous phone call at his home which he definitely knew was the voice of Giorno. The caller stated that he was going to blow the heads off of Parise and his family and then hung up. Parise advised that since that time he had been plagued with annoying calls whereby the phone rang and when it was answered there was no one at the other end. It was Parise's opinion that Giorno was responsible for the calls. (S)(U)
