SUBJECT: JUNE COBB
INTERNAL SECURITY - CUBA

Subject is an American citizen [who has been utilized as a source of information by Central Intelligence Agency (CIA) in Cuba. CIA has been able to maintain personal contact with her only when she makes a visit to the United States.] Several weeks ago we asked [CIA] to check with Cobb in order to determine if she was in possession of any information concerning the alleged existence of a communist cell in the American Embassy, Havana. We had received such an allegation from John Speller, who claimed that he had received his information from a number of sources, including subject.

On September 28, 1960, [redacted] CIA, advised that Cobb was recently interviewed concerning this matter. She stated that she had no information concerning any communist cell in our Embassy in Havana.
