Reference is made to Miami airtel dated November 14, 1960. Miami furnished information indicating that subject was in possession of names, a phone number and address indicating the possibility that Central Intelligence Agency (CIA) has been in contact with the subject and was being utilized by that Agency. This matter was discussed by the Liaison Agent with Birch O'Neal and [redacted] SCIA, on November 17, 1960. They advised that CIA definitely is not utilizing Valdes in any capacity. As previously reported, CIA has been interested in possibly contacting the subject with a view of recruiting him for an intelligence assignment in Cuba. O'Neal stated that such action is being withheld until the Bureau completed its investigation and the contact would be made only if there were not any Bureau objection. *(Handwritten mark)*

With regard to the names, address and phone number in possession of subject, [redacted] advised that he has no explanation for this but suggested the possibility that Valdes could have obtained such information from other Cuban exiles. [redacted] does not feel that the possession of such information means that he is being used in a CIA operation. [redacted] also added that personnel of the Frente Revolucionario Democratico may have had contact with Valdes and have not reported the matter to any CIA representative. *(Handwritten mark)*
