Reference is made to a phone call from ASAC Schmit of your office to Mr. W. A. Branigan of the Bureau on 7/10/61.

(S) [redacted] On 7/13/61 CIA was contacted by liaison and advised that [redacted] was upset because he has not been contacted by that Agency. CIA representative subsequently advised that CIA has not been able to arrange proper type of assignment for [redacted] to date, but is (S) definitely very much interested in him. CIA representative further advised that an official of CIA will be contacting [redacted] in the very near future. (S)

(S) The foregoing is (S) for your information. You should not offer any advice to [redacted] relative to his dealings with CIA. (S) Keep Bureau advised of any additional information you might receive concerning this matter. (S)
