1. <sup>FBI</sup> ~~ODENVY~~ SAYS THEIR FOLLOW-UP INVESTIGATION OF OSWALD'S ACTIVITIES HAS PRODUCED "RELIABLE INDICATIONS" THAT HE WAS IN NEW ORLEANS ON 19 SEPTEMBER 1963 REPEAT 19 SEPTIMBER 1963.
