CG SIXTY SIX FOURTEEN DASH C ADVISED GUS ALEX JOINED PIERCE AT STOFFER'S RESTAURANT, LOOP AREA, CHICAGO, ON MAY SECOND LAST. AFTER SHORT MEETING ALEX AND PIERCE WERE PICKED UP IN AUTO DRIVEN BY HY GODFREY, CHAUFFEUR AND ERRAND BOY FOR DECEASED HOODLUMS HUMPHREYS AND FERRARO. THEY THEN LEFT LOOP AREA HEADING WEST IN DIRECTION OF USUAL MEETING PLACE OF PAUL DE LUCIA. SINCE PIERCE INDICATED EXTREME INTEREST IN DE LUCIA'S SITUATION DURING CHANCE MEETING APRIL TWENTY NINE LAST AND SINCE IT APPEARS PIERCE HAS TAKEN OVER SOME RESPONSIBILITY OF HUMPHREYS FOR STRATEGY TO BE USED IN LEGAL SITUATIONS INVOLVING HEADS ORGANIZED CRIME HERE, IT IS POSSIBLE PIERCE AND ALEX HAD MEET SCHEDULED WITH DE LUCIA.
