ANNEX "B" TO CR NR 1-G-OR-55-67,

dtd 17 Feb 67, re: Pers Mtg w/ SD-15332

**CONFIDENTIAL**

a. C/O inquired of SD-15332 HIS knowledge of SD-15832. SD-15332 revealed that ~~HE~~ has never had any close ties of friendship with SD-15832; that their association was one of casual acquaintances from the same neighborhood in CUBA. SD-15332 stated that HE sees SD-15832 occasionally in MIAMI.

b. SD-15332 stated that HE recommended SD-15832 to the C/O as a result of the C/O's request for a recommendation of an individual who knows SD-15119 and who had the capability to infiltrate CUBA. However, SD-15332 stated that HE personally did not think SD-15832 was a good candidate because SD-15832 talks too much of HIS alleged clandestine infiltration activities.

c. SD-15332 informed that SD-15832 had bragged about HIS activities of infiltration/exfiltration of CUBA in the past; however, SD-15332 does not know when, where, how nor the purpose for SD-15832's alleged clandestine infiltrations. C/O instructed SD-15332 to attempt to learn what experience, if any, SD-15832 has regarding infiltration into CUBA, to include but not necessarily limited to the times, the dates, the places, the means used and with what support organization or group. C/O cautioned SD-15332 to be discreet in HIS means of obtaining the information in order to avoid arousing SD-15832's suspicion for the purpose ~~of~~ of the information. SD-15332 stated that HE would comply with the C/O's instructions to the best of HIS capability.

a. SD-15332 stated that HE has been unable to meet with SD-15832 under the proper conditions to question SD-15832 regarding his clandestine infiltration experience, as previously requested by the C/O. SD-15332 did not want to arouse SD-15832's curiosity by questioning him point blank.

b. SD-15332 informed that coincidentally the mother of SD-15832 invited SD-15332 and HIS family to an anniversary celebration to be held on 19 March 1967. SD-15332 stated that HE could ask questions of SD-15832 at that time since they will be together under natural circumstances. SD-15332 stated HE can direct a conversation with SD-15832 into the area of information desired. C/O informed SD-15332 that he would contact SD-15832 after the 19 March 1967 to learn of SD-15332's findings.
