Eileen furnished me with some"show and tell" so I could illustrate the fact that documents COULD be opened.It was very complicated to get people in and out the front door withoutencroaching on security. Heasked me what he should do if he found some new documents. I quickly told himto send them on to the ARRB and assured him that once the agency found them,they were required to do so.
