(Counsel to The Honorable James "Pate" Philip, Illinois Senate President) Description of the Call Date: 12/13/95 Subject: Identification Of Files For People Associated With ILIC By The Illinois Senate Legal Counsel Summary of the Call: Anne Buttimer met with several entities of the State of Illinois regarding assassination records of the Illinois Legislative Investigating Commission (ILIC). She made the following notations on 11/30/95 regarding ILIC: "Another problem group. I sent letters to everyone I dealt with. It's best to read the interview report at Issue 33. I suspect a subpoena may be the only way to get them to turn over the records." I spoke with Phil Webber, Esq. today who is counsel to the Senate President James "Pate" Philip. Webber has located files at several locations within the state regarding the following individuals:-Felix "Milwaukee Phil" Alderisio-James Algretti-Sam Battaglia-Fiori Buccieri-Sam Giancana-Alex Gus-James R. Hoffa-Murry "The Camel" Humphreys-Ross Prio-Anthony Spilotro Webber's office has not located any records for Salvatori Alderisio. The are physically located about 45 miles from his office making it necessary to coordinate efforts with other offices. He says it will take a couple of months to secure the files, make copies and send the copies to the Review Board due to staffing and the distance of the files. Webber said he had an agreement with Buttimer for his office to provide copies rather than originals. He will supervise the copying of the material and its shipment to the Review Board. Webber is unsure if the files qualify as assassination records but they are for the names requested by Buttimer. Webber wants to be sure he has satisfied the Review Board's request. * I will send a letter thanking him for locating the files and that we would appreciate having the files sent as soon as possible.
