DAVE CALL REPORT ISSUE # 41 DOCUMENT'S AUTHOR: DAVE MONTAGUE/ARRB DATE CREATED: 01/03/96 THE PLAYERS DESCRIPTION OF THE CALL DATE: 01/03/96 SUBJECT: 2nd ATTEMPT TO LOCATE RECORDS RE: AGREEMENT BETWEEN THE DEPARTMENT OF ENERGY, LOS ALAMOS LABORATORY AND AEROSPACE CORPORATION SUMMARY OF THE CALL: I SPOKE WITH SKIP GOSLING WHO IS THE CHIEF HISTORIAN FOR THE U.S. DEPARTMENT OF ENERGY'S (DOE) HISTORY DIVISION. I WAS REFERRED TO HIM BY BELINDA HOOD OF THE DOE. I TOLD HIM THAT I AM ATTEMPTING TO LOCATE ANY RECORDS REGARDING AN AGREEMENT BETWEEN THE DEPARTMENT OF ENERGY, LOS ALAMOS LABORATORY AND AEROSPACE CORPORATION TO VIEW THE NIX FILM AND OTHER ASSASSINATION RELATED MATERIAL ON BEHALF OF THE HSCA. GOSLING APOLOGIZED FOR NOT RESPONDING IN A TIMELY MANNER BUT ASSURED ME THAT HE WILL HAVE HIS ARCHIVIST LOOK FOR ANY RECORDS STARTING NEXT WEEK. I TOLD HIM I WILL BE SENDING AN INFORMATION PACKET SO HE WILL UNDERSTAND THE NATURE OF THE REVIEW BOARD IN HIS SEARCH FOR RECORDS. ARCHIVIST BETSY SCROGER OF THE HISTORY DIVISION WILL BE THE ARRB'S CONTACT DURING THE SEARCH PROCESS AND SHE WILL MOST LIKELY BE THE PERSON RESPONDING TO MY REQUEST. GOSLING: BY WAY OF INTRODUCTION, THE ASSASSINATION RECORDS REVIEW BOARD (ARRB) IS AN INDEPENDENT FEDERAL AGENCY CREATED TO OVERSEE THE IDENTIFICATION AND RELEASE OF RECORDS RELATED TO THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY. THE ARRB WAS ESTABLISHED BY THE PRESIDENT JOHN F. KENNEDY ASSASSINATION RECORDS COLLECTION ACT OF 1992 (PL 102-526) AND WAS SIGNED INTO LAW BY PRESIDENT GEORGE BUSH. THE LAW GIVES THE ARRB THE MANDATE AND AUTHORITY TO IDENTIFY, SECURE, AND MAKE AVAILABLE ALL RECORDS RELATED TO THE ASSASSINATION OF PRESIDENT KENNEDY. I AM ENCLOSED A COPY OF THE ACT AND SOME EXPLANATORY MATERIAL. THE SCOPE OF THE REVIEW BOARD'S MANDATE INCLUDES ASSASSINATION-RELATED RECORDS IN THE CUSTODY OF FEDERAL AGENCIES, LOCAL AND STATE GOVERNMENT ENTITIES, AS WELL AS THOSE IN THE PRIVATE SECTOR. FROM OUR TELEPHONE CONVERSATION I UNDERSTAND YOUR OFFICE MAY HAVE ASSASSINATION RELATED RECORDS CONCERNING AN AGREEMENT BETWEEN THE DEPARTMENT OF ENERGY, HOUSE SELECT COMMITTEE ON ASSASSINATIONS (HSCA), LOS ALAMOS LABORATORY AND THE AEROSPACE CORPORATION. THE ORVILLE NIX FILM, MARIE MUCHMORE FILM, ZAPRUDER FILM, AUTOPSY X-RAYS AND PHOTOS WERE IN THE RECORD
