My limited knowledge of yourBoard's activities has been acquired largely through the efforts ofJohn Newman, the author of "Oswald and the CIA." Newsweek magazine wasgood enough to send me your address in Washington. Not only as a researcher, but also as a tax-paying citizen, I amcurious to know if you have published any progress or summary reportsfor public consumption regarding the Review Board's operations. If anymaterial is available, I would appreciated receiving copies. Also, ifI were to inquire about a specific document, how would I go about gettinga copy? It is largely up to the public to squeeze out assassination infor-mation which has been locked up. The process is slow, but from my readings, a number of extremely important facts have been revealed recently. It is of little comfort to look back to the remarks to thepress by then chairman of the Senate Intelligence Committee, DavidBoren on 3/27/92 that he had no reason to believe that the files [ofsecret documents] would reveal "any comprehensive government conspiracyor illegal activity." Also, it is disturbing to listen to the SenateIntelligence Committee's current hearings chaired by none other thanSenator Arlen Specter who played a major role in covering up the factssurrounding the execution of President Kennedy.
