Review Board's representative in the call: Dave MontagueSubject: Confirmation on location of Carl Belcher (former Chief of DOJ's General Crimes Section in 1963) re: JFK inventoryDescription of the Call Medical ProjectI spoke with Carl's wife who identified herself as Nada today & she said she didn't know if he was involved with the JFK autopsy or an inventory, but said "...he used to be the head of the Crimes Section at DOJ a long time ago...". Nada said Carl was working today & that their daughter was currently in town visiting, from Vienna. I asked if he still works for DOJ, to which she said no. Nada explained that Carl was a very prominent attorney with DOJ at one time & how old coworkers who are still at DOJ always say "We need people like you again who know how to win cases.". She wanted me to know that he was a very good attorney & he did a lot of work (at one point) for INTERPOL. She said even though Carl traveled at the expense of the government, he paid for & carried her all over the world with him. Our conversation never steered back to discussion re: JFK, so I told her I'd send Carl some information on the Review Board & that someone would follow-up with him in the future. Nada said that would be fine, but that he'd probably rather wait until their daughter leaves (about 1 week) before being interviewed in-depth. I said that would be just fine as well.I verified their address, her first name (which matches the named retrieved from his St. Louis personnel file) & thanked her for her time.*It is noted that the ss# retrieved from Carl's personnel file was "[Screened by: NARA RD-F on October 20, 2016 according to the John F. Kennedy Records Collection Act of 1992, 44 U.S.C. 2107, Section 6(3)]" & that this is the same record which showed his dob, wife's name & his being head of the General Crimes Section in 1963.
