Jeremy: I've done all the searching I could out at NARA II: no luck on finding any definitive record (receipt, billing record, etc.) of the 9/18/64 transcript having been made.  
Dave: 1) To confirm our conversation of earlier this afternoon, the middle initial of Jesse Ward, Jr. and Jesse Ward III is "L." Jesse Jr. was probably middle-aged in 1964 and Jesse III a young man. 2) Additional Ward & Paul name: Alma Paul Wick. 3) WC staffers expressly authorized to deal with Ward & Paul on transcripts, etc. (addresses circa 1964): Howard Willens - 5002 Hurst Terrace, NW, Wash. DC Julia T. Eide - 4550 MacArthur Blve., Wash. DC OR 924 E. Juneau, Milwaukee WI 53202 Beverly A. Heckman - 4410 Hallet St. Rockville MD 20853 Anne V. Walsh - 4990 Columbia Pike, Arlington VA 22204 OR 857 S. Glebe Rd. Arlington, VA [Walsh was a DOD detailee, if that's of any value] Of this WC group, Steve Tilley believes Howard Willens was still practicing law in DC until sometime recently. Sure enough, there's a Howard P. Willens listed as a lawyer in DC at 2445 M Street (663-6000) in the DC phone book. Willens, on loan from DoJ, was Rankin's right-hand man, administra- tively. Pending the locating of Jesse Ward, Jr. or Jesse Ward III, Willens is probably the best place to start.  
Tom: I gather you've been dealing with J. Lee Rankin's son. Rankin's papers would be another place worth looking for evidence regarding whether a transcript was ever made of the 9/18 meeting.  
Jeremy: Let me know if you want me to contact Willens, or if someone else should.
