Subject:	MCC "Criminal Organization" files

Yesterday, I talked to Kay Sloan of CBD Docusource in New Orleans. Her company has now finished copying all of the MCC materials that I asked them to copy, including the "Warren DeBrueys" MCC boxes. She told me that she would send the copies to us by FedEx today.CBD has a couple of boxes of archival paper left over that we should use in the copying of the MCC "criminal organization" files. As I mentioned in my September 9 memo to you, the MCC has not yet decided whether it will do the copying itself (in which case I will just have CBD Docusource deliver the paper to the MCC offices) or whether to have CBD do the copying. I think that Tony Radosti would prefer for MCC staff to do the copying, unless the job is too time-consuming. Of course, if the MCC does the copying itself, it would be cheaper for us, but I do not know whether they would be as careful or thorough as CBD has been. In any case, we need to let the MCC know which files we want copied. As I charted in my memo to you, there were nine "criminal organization" files referenced in the HSCA's OCR from their review of MCC files. Of those nine, I found six files still in existence at the MCC offices. Clearly, we want to copy these -- they are very short and will not take long to copy. As you can also see in my memo, the Marcello "criminal org." file is a different story. We need to decide which sections we want to copy so that we can get started with the copying. My inclination is to copy Volumes 1-9 (1954 through 8/65) and Volumes 34 and 35 (1977-1978) of the main volumes, and then "Carlos Marcello Deportation, Volumes I and II." It might also make sense to copy the file: "MCC Charts of the Marcello Organization" and maybe some of the files on arrest records, financial data, property ownership, telephone records, etc. . . . Our other option is to copy all four file drawers, with the exception of any hearing transcripts that are publicly available through the Library of Congress and other libraries. When you all have a chance to again review my memo, please let me know what your sense is about copying the Marcello file. Thanks. Record
