In some instances, I have sent them on to you in J-track and am awaiting further instruction; in others, I am still working on them.GEORGE DeMORHENSCHIDLT SUB-PROJECT1. Locate Willem Oltmans and send letter requesting information. STATUS: I have reviewed the HSCA numbered files and determined Oltmans known address as of 1978 when the HSCA was in contact with him. Additionally, I have identified about 25 instances where Oltmans' name appears in the numbered files and will be reviewing those records for any pertinent information. Oltmans' last known address has been given to Dave Montague, who willnow attempt to track him down.2. Talk to Epstein, DeMohrenschildt's lawyer. No progress; project has not yet been initiated.SHEFFIELD EDWARDS SUB-PROJECT1. Determine whether interviews are in CIA sequestered collection. The interviews in question are referred to in two RIFs in the collection. I have pulled the RIF's, and am preparing a memo to Barry (to be routed through Bob) requesting that those documents be delivered to ARRB for my review. This task is completed.2. Request records from CIA if not in collection. The request memo will be sent out by the end of the week.CUBA RELATED SUB-PROJECTS1. Compile list of Florida-related projects. A draft version of this list was submitted at the beginning of last week. I am awaiting suggested revisions or discussion of this area. This task, so far as I know, is completed.2. Request (Veciana, et al.) records from Army. We have internally discussed the need to return to IRR, designate the files on Veciana and others as assassination records, take posession of them and review them here at ARRB. Upon receiving approval for another trip up there, we will proceed to do this in coordination with IRR and the Army.LANSDALE SUB-PROJECTThis sub-project is still listed as incomplete, but I am unaware at this time of anything else that we need to do on it. The Hoover Institution's records are all unclassed, thus negating the need for us to handle them. Please advise as to what else we can do.AYERS SUB-PROJECTThis is another item listed as incomplete, while I remain unaware of any need for further action. The tasking in the sub-project refers to "response to Ayers' letters." I do not have any recollection or knowledge of any contact with Brad Ayers since my interview with him in May of 1995. Is there something I either forgot or that may have slipped through the cracks somewhere? Please advise as to what I should be doing to complete this tasking. Record
